QUESTIONS AND ANSWERS THROUGH 10:00AM ON FEBRUARY 29, 2016

- Q#1 Will the new ODOT prequalification requirements of all painting contractors being certified by the SSPS QP 1 and QP2 by July 1 2016 be required on all Turnpike painting projects coming out for bid? These are new requirements by ODOT this year.
- A#1 As per SP 514A, 1.08.A, "All painting Contractors and/or Painting Subcontractors to be used for lead paint removal, containment, collection and handling, surface preparation or coating of structural steel must be certified and included on the Pre-qualified Painting Contractors List as maintained by ODOT before the day of bid opening. All Painting Contractors and/or painting subcontractors must remain so certified for the duration of the Project." (emphasis added).

Accordingly, bidders must be prequalified at the time of bid opening and the contractor must maintain eligibility for prequalification when the standards change on July 1, 2016 through obtaining the additional required certification.

- Q#2 Two bid items for Ref. 6 appear on the bid schedule, please confirm that both are intended to remain in the bid schedule of items.
- A#2 The bid schedule inadvertently contains two bid items labeled as Ref. 6, and the Commission seeks bids on both reference items. Through this Addendum No. 1, the Commission is renumbering one bid item as "Ref. 6A" on the bid schedule of items.

MODIFICATIONS TO THE CONTRACT DOCUMENTS

The Cover Page and Notice to Bidders is modified to extend the bid opening date from 2:00PM on March 2, 2016 to 2:00PM on March 9, 2016.
