Bids will be received for Project No. 43-16-04, which includes the following:

Replacement of bridge decks, bearing devices and expansion joints; sealing of construction joints; performing concrete weatherproofing; maintenance of traffic; and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 43-16-04.

Bids will be accepted until **December 4, 2015, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. To avoid a potential extension of the Bid
