Work also includes the installation of a Diesel Exhaust Fluid (DEF) system, including underground storage tank, submersible DEF pump, remote fill, DEF piping, and all other related components as indicated on the Contract Drawings at both service plazas. Vehicular and pedestrian traffic control and job site fencing are to be performed by the Contractor. The work will be performed at the westbound Portage Service Plaza and the eastbound Brady's Leap Service Plaza, both of which are near Freedom, Ohio. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project Nos. 53-17-02 and 53-17-03 (Re-Bid).
