Removal by milling of three (3) inches of existing asphalt pavement in the left and right lane of the mainline, removal by milling of two (2) inches of existing asphalt in the left and right shoulders, mill and fill of the Sonic Nap Alert Pattern ("SNAPs") in the left and right shoulder, resurfacing of the pavement and shoulders to the thickness specified in the Drawings, concrete weatherproofing of bridges, approach slab repairs, full depth pavement repairs, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, upgrading of guardrail, installation of SNAPs, and temporary traffic control, in both Eastbound and Westbound lanes from Milepost 38.90 to Milepost 43.30.
