Sealed Bids will be received by the Ohio Turnpike and Infrastructure Commission (“Commission”) from Bidders subscribing to Bid Express (<https://www.bidexpress.com>) and selecting the following Project for Bidding:

Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

**Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.**

**The Small Business Enterprise (DBE/EDGE/SBE) Goal applicable to this Project is 9%.**

**Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2.1 for this Project.**

Bids will be received for Project No. 59-17-01, which includes the following:

Removal by milling of two (2) inches of existing asphalt pavement in the center lane and right lane of the mainline, removal by milling of two (2) inches of existing asphalt pavement in right shoulder for select locations, mill and fill of the Sonic Nap Alert Pattern (“SNAPs”) in the left shoulder, resurfacing of the pavement and shoulders to the thickness specified in the Drawings, concrete weatherproofing of bridges, full depth pavement repairs, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, upgrading of guardrail, installation of SNAPs, and temporary traffic control, in both Eastbound and Westbound lanes. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 59-17-01.

Bids will be accepted until **February 14, 2017, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
