Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2.1 for this Project.

Bids will be received for Project No. 70-17-01, which includes the following:

Rehabilitation of specified roadway embankments; full depth removal and replacement of shoulder pavement, repair of mainline catch basins and associated conduits; removal, replacement and/or upgrade of existing guardrail; permanent pavement striping and/or other pavement markings, installation of SNAP’s; temporary traffic control and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 70-17-01.
