Reinstall metal fascia system and drains (provide and connect associated piping). Demolish fiberglass fascia system. Provide and install new fiberglass fascia system. Demolish all exterior Dryvit finish. Provide and install new exterior cement board finish system. Demolish entire metal soffit system. Provide and install new metal soffit system. Demolish light fixtures, access doors and cameras and specified junction boxes, conduit and wiring. Provide and install new light fixtures, access doors, cameras and specified junction boxes, conduit and wiring.

Clean brick and seal. All typical finish caulks, sealants, trim, etc. All other Work incidental to these major items is shown on the Drawings and/or specified in the Specifications and these Special Provisions.
