ANSWERS TO QUESTIONS RECEIVED THROUGH 4:00 PM JULY 28, 2016

- Q#1 When does the project have to be completed?
- A#1 See SP 103 Access and Time of Completion on Page 8 (SP-2) and (SP-3), which states: "The Commission anticipates providing access to the Blue Heron and Wyandot Service Plazas south of Genoa, Ohio at Milepost 76.9 on or about August 29, 2016. The Contractor shall achieve final completion of all work within 21 days of Commencement of Work at the site or September 30, 2016, whichever occurs first."
- Q#2 Is it going to be double coated?
- A#2 Yes. The Note on Sheet 2 of 4, Item Special Asphalt Concrete Pavement Sealing, provides that, "THIS ITEM OF WORK SHALL CONSIST OF FURNISHING AND APPLYING A MINIMUM OF TWO (2) COATS OF ASPHLAT EMULSION SEALCOAT TO THE ASPHALT PAVEMENT AREAS DEPICTED IN THE PLANS."
- Q#3 How can we get to the plaza food court to attend the pre-bid?
- A#3 There are two ways to access the food court at the Blue Heron Service Plaza (<u>north</u> of the Turnpike) to attend the pre-bid meeting on August 2, 2016 at 10:00AM:
 - 1. The toll payer's entrance: From Turnpike's westbound lanes of travel after entering the mainline anywhere east of Milepost 76.9 (i.e., State Route 51 south of Elmore or any points east), and accessing the Service Plaza using the exit at Milepost 76.9 from the mainline of the Turnpike. After the meeting, attendees must then re-enter the mainline again heading westbound and exit the Turnpike after paying the applicable toll from the westbound lanes of travel. No U-Turns are permitted on the Turnpike mainline.
 - 2. The employees' entrance: From the access drive off County Road 165 (Trapp Road) west of County Road 30 (Main Street/Lime Road) south of Genoa, Ohio and parking outside the gates in the rear lot just past the water tower. Attendees can access the food court in the plaza from the parking lot without paying the toll after walking through the fence opening onto the plaza grounds.

While attendance at pre-bid is not mandatory, the Commission strongly encourages bidders to attend so the Commission can callout important aspects of the invitation to bid.
