## ANSWERS TO QUESTIONS RECEIVED THROUGH 12:00 P.M. ON NOVEMBER 30, 2018:

- Q#10 We have made contact with every Concrete Ready-Mix Supplier within the radius required for this Project. Each Ready Mix Supplier has declined to provide pricing to supply concrete for this Project. Is the Turnpike aware of any Concrete Ready Mix Supplier who is capable of supplying concrete for this Project and who will be quoting the Project?
- A#10 The Commission has contacted concrete suppliers that appear to be within the radius required for this project. The Commission explained the nature of the project and its requirements for materials, and the suppliers identified below indicated a potential willingness to participate in the project. The list below is not all-encompassing or attesting to the suppliers' ability to meet specifications. Rather, those identified are provided to share information available to the Commission with potential bidders.

<u>Castalia Trenching</u>, (419) 684-5502. Castalia Plant. This vendor may be out of the radius for the bridges at Milepost 131.6 and 135.4.

Elyria Concrete, (440) 355-5825. Castalia and Lagrange Plants

<u>Concrete Material Supply</u>, (419) 261-0246 or (419) 547-8998. Sandusky Plant. This vendor may be out of the radius for the bridges at Milepost 131.6 and 135.4.

Medina Supply, (800) 341-6808. Note this vendor appears to be out of the radius for the bridges at Milepost 120.0, 121.9, and 123.1.
