

Q#4 SP 104 G. Access for all material delivery and/or construction equipment shall be achieved through public Toll Plaza ramps only. No access drives, maintenance buildings facilities, service plazas or back-gate entrance locations will be permitted for use without prior written approval of the chief Engineer. There is currently no fence cut options on the BID Express website. Is the intent of this project only to ingress / egress through Toll Plaza ramps or will a fence cut option be provided? If the fence cut option is not provided, will trucks be able to turnaround at MP 91 (Fremont) with the upcoming OTC Project at that location or will access to the back-gate to Erie Islands be provided?

A#4 The Commission will accept offers for a Temporary Access Deduct Alternate Credit allowing the Contractor to propose an alternate ingress/egress option and the credit associated with the Commission's acceptance of that option. Alternatively or additionally, the Contractor may propose a Temporary Access Deduct Alternate Credit for using the Erie Islands back access gate for project traffic and the credit associated with the Commission's acceptance of that option. The Contractor will be permitted to use Exit 91, without providing Temporary Access Deduct Alternate Credit(s), to turn around project traffic, provided the Contractor provides an appropriate traffic control plan, including a flagger, for approval by the Chief Engineer. If the Contractor chooses not to provide a Temporary Access Deduct Alternate Credit, the Contractor will be required to use the toll plaza entrance or exit ramps for project access.

The Commission is modifying the Bid Form to include deduct alternate credits for Temporary Access at a site or sites of the Bidder's choosing and/or back gate access at the Erie Islands Service Plaza. Bidders may elect to offer deduct credits for neither, one or both alternates provided. Bidders offering credits for both alternates should specify whether the credits are additive, exclusionary or both. In other words, the Bidders offering credits for both deduct alternates should state whether the Commission has the option of choosing both alternates together, one alternate between the two offered or either both or one alternate at the option of the Commission. The Commission will evaluate the bid alternates in accordance with Instructions to Bidders Article 2.6.3 and 3.5.1.

The following changes are made to the Contract Documents for Contract No. 53-16-02:

The Bid Form is modified to provide for offering the Temporary Access Deduct Alternate Credits described above.
