Bids will be received for Project No. 43-15-03, which includes the following:

Scope of Work - (Part A):

Repair of bridge components, including: patching deteriorated concrete; rehabilitation and/or replacing bearing devices and expansion joints; refurbishing bridge deck; sealing of construction joints; performing concrete weatherproofing; maintenance of traffic; and all other items incidental to the completion of the Work.

Scope of Work - (Part B):

Replacement of bridge deck, bearing devices and expansion joints; miscellaneous patching of substructure; sealing of construction joints; performing concrete weatherproofing; maintenance of traffic; and all other items incidental to the completion of the Work.

Scope of Work - (Part C):

Placement of an access road including: clearing and grubbing; excavation; subgrade compaction; placement of asphalt pavement and concrete curb and gutter; and all other items incidental to the completion of the Work.

All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 43-15-03. Although the Scope of Work is listed in Parts, the Project will be awarded to a single Bidder.
