- Q#1 How is traffic is to be maintained under the Ramp MP 232.9 structures? There is an existing concrete divider which spans the entire length of the ramp making it impossible to maintain even a one lane two-way traffic operation with flaggers. Please advise.
- A#1 Plan Sheets 20A and 20B of 20 have been added to the plan set to provide the maintenance of traffic required to perform the painting while maintaining one lane of ramp traffic at all times. OTIC maintenance forces will remove the existing concrete median and then replace it after the project is completed.
