Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder' Risk Insurance is not required under GC Art. 12.2 for this Project.

Bids will be received for:

Removing and reconstructing the pavement in the right two (2) lanes and shoulder in both directions of the Ohio Turnpike. The Work includes, but is not limited to, excavating existing pavement, full depth asphalt paving, chemically stabilizing the subgrade, making minor slope repairs, performing drainage repairs and replacements, including the relining of culverts, installing concrete barrier wall, asphalt curbs, guardrail, pavement markings and other traffic control devices, performing temporary traffic control and performing bridge maintenance on three (3) structures. The bridge maintenance Work includes, but is not limited to, approach slab replacements, conducting replacements, patching concrete, resetting, repairing and replacing bearings, removing and replacing expansion joint armor and associated concrete repairs, removing and replacing the expansion joint seals, repair and painting of structural steel and concrete weatherproofing. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Contract No. 39-14-01.

Bids will be accepted until **February 19, 2014, at 2:00 P.M.** (**E.S.T.**), when all Bids will be accessed, opened and read aloud.
