### ANSWERS TO QUESTIONS RECEIVED THROUGH 12:00 P.M., May 30, 2012

- Q#1 Proposal pages GC-65 and GC-66 call for Contractor's Pollution Liability with a specification that begins with "If Work performed or provided by Contractor includes activities that could result in or give rise to a contamination or pollution incident, the Contractor shall purchase and maintain in force insurance covering loss and liability arising out of or relating to Work." Please verify if the contractor will or will not be required to provide a Contractor Pollution Liability policy
- A#1 Contractors Pollution Liability coverage is required.
- Q#2 Proposal pages GC-66 and GC-67 call for Builder's Risk Insurance with a specification that begins with "Where the Contract requires Builders Risk Insurance..." Please verify if the contractor will or will not be required to provide Builder's Risk insurance.
- A#2 Builders Risk coverage is not required.
- Q#3 Proposal pages SP-20 and SP-21 call for a zone person and zone vehicle on the project. In the zone person note, it states that if not separately itemized that the zone person and vehicle shall be considered incidental to SP-614. Given the non-mainline nature of work on this project, will the OTC please modify and/or waive the zone person and zone vehicle requirement?
- A#3 If the Contractor's means and methods require a lane closure on the Ohio Turnpike mainline or ramp, then a zone person and zone vehicle shall be required in accordance with SP 614.
- Q#4 Plan sheets 10 and 12 show existing temporary barricades that go across Yorktown Road. Will the OTC remove these or is the contractor supposed to remove these? If the contractor is to remove these, then will OTC provide a location for disposal/storage of these items?
- A#4 The existing temporary barricades and gates will be removed by the Sandusky County Engineer's Office. The Contractor shall coordinate the installation of the Contractor's detour route and barricades with the removal of the County's.
