Bids will be received for:

Installation of new catch basins and connected piping, installation of underdrains, installation of new full depth pavement by excavating a portion of the existing aggregate material and installing asphalt concrete base, intermediate and surface courses. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 56-14-01.
