Sealed Bids will be received by the Ohio Turnpike and Infrastructure Commission (“Commission”) from Bidders subscribing to Bid Express (<https://www.bidexpress.com>) and selecting the following Project for Bidding:

Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.

All Bidders entering into a Contract on a Commission-administered Project and their Subcontractors will be required to be enrolled, and in good standing in a “Drug-Free Safety Program” approved by the Ohio Bureau of Workers’ Compensation.

Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2 for this Project.

Bids will be received for:

Removal by milling of two (2) inches of existing asphalt pavement in the left and right lane of the mainline, removal by milling of two (2) inches of existing asphalt in the left and right shoulders, mill and fill of the Sonic Nap Alert Pattern (“SNAPs”) in the left and right shoulder, resurfacing of the pavement and shoulders to the thickness specified in the Drawings, concrete weatherproofing of bridges, approach slab repairs, full depth pavement repairs, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, upgrading of guardrail, installation of SNAPs, and temporary traffic control, in both Eastbound and Westbound lanes from Milepost

0.00 to Milepost 5.70. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 59-15-01.

Bids will be accepted until **January 15, 2015, at 2:00 P.M (E.S.T.)**, when all Bids will be accessed, opened and read aloud. To avoid a potential extension of the Bid Opening date and/or a potential rejection of all Bids, it is imperative that Bidders submit all questions in a timely manner and no later than seven (7) days prior to Bid Opening.
