ANSWERS TO QUESTIONS RECEIVED THROUGH THE END OF THE INQUIRY PERIOD, 5:00 P.M. (E.S.T.), MARCH 7, 2013:

Q#1 What are the current spends for the 3 RFP packets that are out for bid?

A#1 Be advised that the requirements under the these RFPs are different than those contained in the current and previous Contracts for Janitorial Services, and they provide the Selected Contractor(s) with more flexibility in managing operating expenses. Keeping the incomparability in mind, the rates under the current Contracts for the Janitorial Services at the Service Plazas are as follows.

Indian Meadow and Tiffin River Service Plazas, commencing June 20, 2011: \$22,911 74 per plaza, per month, and \$9.92 per hour for approved additional labor;

Blue Heron and Wyondot Service Plazas, commencing May 1, 2011 \$20,956 77 per plaza, per month and \$9.86 per hour for approved additional labor, and

Middle Ridge and Vermilion Valley Service Plaza, commencing August 1, 2008: \$23,575 per plaza, per month and \$9 70 per hour for approved additional labor.

Q#2 If my organization is bidding all 3, would it be acceptable to provide a discount percentage if awarded multiple facilities? If so, how would you like that presented?

- A#2 Yes, the Commission encourages Responding Contractors to utilize economies of scale to submit discounted Price Proposals for multiple facilities. Each RFP provides Responding Operators with an opportunity to submit Optional Combined Proposal for multiple Service Plaza Pairs under PART III, Section C The Optional Combined Price Proposal contemplates that Responding Firms will submit a total lump sum monthly fee to perform the Janitorial Services for various Service Plazas combinations. However, the Commission will entertain alternative percent discounts or other Price Proposal incentives to award a Responding Firm a Contract for multiple facilities.
- Q#3 If I'm reading things correctly, there are no set supervisory hours requested by the Commission. Are the amount of these hours left up to the contractor to decide, or is there a minimum amount of supervisor hours per shift that the Commission would like to see.
- A#3 There are no minimum mandatory supervisory hours specified However, the Selected Contractor is required to furnish sufficient "on-site supervisory staff to assure that the

Standards of the Agreement are consistently met throughout the term" and to "effectively manage and successfully accomplish the scope of services required set forth in the RFP, with special attention given during Peak Travel Periods and Peak Holiday Periods (i.e., summer, holidays, and weekends)" See, PART II, Section C of the RFP The sufficiency and adequacy of the supervisory personnel will be determined by performance, not hours worked
