# Division Landscaper Hiram Maintenance Building – Division II OHIO TURNPIKE & INFRASTRUCTURE COMMISSION

The Ohio Turnpike Commission is seeking an <u>experienced</u> Landscaper to work in our Maintenance Department – Hiram Maintenance Building – Division II. Qualified individuals must have experience and applicable training in the field of commercial landscaping. A valid Class "A" Commercial Driver's License (CDL) with a tanker endorsement is required. Individuals are also required to reside within approximately a twenty-five (25) mile radius of the division installation assigned to by date of hire. Must possess an Ohio Commercial Applicator Pesticide License as a minimum, but not limited to categories 5A, 6A and 8, through the Ohio Department of Agriculture.

Must have knowledge of landscaping and applicable regulations and practice; operation of tools and equipment; safety practices\*; agency policies and procedures\*. Skill in operating hand and power tools related to landscaping. Ability to understand plans and assignments; work alone on tasks; stand, walk or bend continuously; lift and carry 40 pounds frequently and 80 pounds occasionally; use mechanical equipment; radio and telephone communications\*; use limbs/fingers easily to perform manual tasks. Assigned to an approximate 120-mile section of roadway (Division I) with the ability to drive throughout the distance of the Ohio Turnpike.

Maintain, construct, and repair landscaping. Applies pesticide treatment of roadside vegetation, ornamentals and turf grass; construction of landscapes; prune, trim, and clear trees, brush, shrubs, etc. Performs snow and ice removal operations when required and any other duties as may be assigned by the Trades Supervisor.

## SALARY

Starting salary is \$19.89 hourly plus excellent benefits to start. Salary increases with OTIC service.

Normal working hours: 8:00 a.m. – 4:00 p.m. (winter) 7:00 a.m. – 3:00 p.m. (summer). Available to work overtime during on-call hours and when necessary, considerable overtime may be required.
