# Maintenance Worker Class II Roadway Boston Maintenance Building OHIO TURNPIKE & INFRASTRUCTURE COMMISSION

The Ohio Turnpike & Infrastructure Commission is seeking a Maintenance Worker - Roadway employee to work in our Maintenance Department - Boston location. Qualified candidates must <u>currently</u> possess a valid Class "A" Commercial Driver's License (CDL) with a tanker endorsement. Candidates are required to reside within approximately a twenty (20) mile radius of the maintenance building.

Must have knowledge of highway and building maintenance practices and procedures. Must be skilled in the operation and use of a variety of construction tools and heavy equipment including loader, dozer, backhoe, asphalt roller, asphalt paver, hand and garden tools, saws, mowers, jackhammers, trucks, etc. Must possess the ability to perform the duties that are necessary for snow and ice control operations including plowing and spreading salt with single/tandem axle dump trucks; construction projects with building materials (wood, concrete, asphalt, steel, etc.), traffic control, communications, and safety equipment. Must be able to work alone; stand, walk and bend continuously; lift and carry 40 pounds frequently and 80 pounds occasionally.

Assigned daily duties in the operation of vehicles and equipment; performs labor in connection with the repair and maintenance of turnpike facilities including concrete and asphalt roadway, service plazas, access roads, bridges, toll plaza ramps and lanes; drainage; mowing; guardrail and fences; snow and ice removal; equipment preparation; paint buildings, facilities and equipment; janitor duties; clean right of way and toll plaza lanes and building; pavement removal and replacement; respond to emergencies, accident scenes, disabled vehicles, surface spills and other incidents; erect traffic control and serve as a flagman; communicate information to/from supervision and the radio room through radio. Perform any other duties as may be assigned.

### **S**ALARY

The starting rate for this position is \$19.89 per hour plus excellent benefits. Salary rate increases with OTIC service.

#### WORK LOCATION

Ohio Turnpike Commission, Boston Maintenance Building, Richfield, Ohio – Summit County Milepost 173.9 Eastbound. Assigned to an approximate 30-mile section of roadway. <u>Employees do not pay tolls to and from their assigned work installation(s)</u>.

## HOURS OF WORK/UNUSUAL WORK CONDITIONS

Must be able to work for extended periods of time, particularly during snow and ice season. Required to be available to work overtime during on-call hours and work overtime in emergency and other situations, considerable overtime may be necessary.

May be exposed to extreme temperatures and weather conditions while working outdoors; climbing ladders and/or scaffolding; working in confined spaces and elevated/high work areas; exposure to fumes, dust, dirt, human blood and body fluids, animal carcasses, unpleasant odors, vibration and loud noise, hazardous materials and surface spills.
