### **Turnpike Commission appoints Jennifer L. Stueber as General Counsel**

**BEREA** (May 18, 2015) – The Ohio Turnpike and Infrastructure Commission today at its regularly scheduled meeting assented to the appointment of Jennifer L. Stueber as General Counsel and Chief Legal Officer.
