Removal by milling of three (3) inches of existing asphalt pavement in the left and right lanes of the mainline, removal by milling of one and one half (1 1/2) inches of existing asphalt in the left and right shoulder, fill of the Sonic Nap Alert Pattern ("SNAPs") in the right and median shoulder, resurfacing of the pavement and shoulders to the thickness specified in the Drawings, full depth pavement repairs, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, upgrading of guardrail, installation of SNAPs, and temporary traffic control, in both Eastbound and Westbound lanes.
