Bids will be received for this Project, which includes the following:

Part A:

Removal by milling of three (3) inches of existing asphalt pavement in the center and right lanes of the mainline, removal by milling of two (2) inches of existing asphalt in the left lane and left and right shoulder, mill and fill of the Sonic Nap Alert Pattern ("SNAPs") in the left shoulder, resurfacing of the pavement and shoulders to the thickness specified in the Drawings, patching of concrete bridge decks and abutment slabs, concrete weatherproofing of bridges, full depth pavement repairs, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, upgrading of guardrail, installation of SNAPs, and temporary traffic control, in both Eastbound and Westbound lanes.

Part B:

Rehabilitation of the bridge deck at M.P. 71.4 by use of hydrodemolition and place a microsilica modified concrete overlay, sealing of construction joints, substructure repair, bearing replacement, performing concrete weatherproofing, maintenance of traffic and all other items incidental to the completion of the Work.

All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.
