Pollution Liability Insurance is required under GC Art. 12.1.3 for this Project.

Bids will be received for this Project, which includes the following:

The Work to be performed under the Contract for Project No. 43-24-03 consists of removing a mainline bridge, embankment construction and replacing with roadway on grade, repairing bridge superstructure components, including: bridge deck replacement, replacing bridge deck joints; rehabilitating bearing devices; substructure repairs; sealing of construction joints; slope repairs; maintenance of traffic; and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **April 3, 2024, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.

Contract Documents are available by registering for a free vendor account and logging into Bid Express® (<https://www.bidexpress.com>). However, Bidders must obtain a paid subscription to Bid Express and select the Project for Bidding to submit a Bid.

The Contract Documents may be reviewed for bidding purposes without charge by registering and logging into Bid Express[®].
