Bids will be received for this Project, which includes the following:

The Work to be performed under the Contract for Project No. 59-23-02, if any is awarded on the basis of the Bids, consists of removing and reconstructing the ramp pavements as shown in the Plans. The Work includes, but is not limited to, excavating existing pavement, constructing full depth pavement, chemically stabilizing the subgrade, performing drainage repairs and replacements, installing concrete median curbing, concrete curbs, upgrading of guardrail, pavement markings and other traffic control devices, installation of SNAPs, and temporary traffic control with detours. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **October 5, 2023, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
