<u>Resolution Awarding Contract No. 43-15-05,</u> Bridge Deck Replacement and Rehabilitation in Fulton and Lucas Counties

WHEREAS, the Commission has duly advertised according to law for bids upon a Contract for Bridge Deck Replacement and Rehabilitation of the Ohio Turnpike Ramp over the Ohio Turnpike at Milepost 34.9, Liberty-Adrian Road over the Ohio Turnpike at Milepost 41.1, and Key Street over the Ohio Turnpike at Milepost 60.8, located in Fulton and Lucas Counties, Ohio, herein designated **Contract No. 43-15-05**; and

WHEREAS, expenditures for the award to be made under Contract No. 43-15-05 will exceed \$150,000.00, and, therefore, in accordance with Article V, Section 1.00 of the Commission's Code of Bylaws, Commission action is necessary for said Contract award; and

WHEREAS, the Commission received two bids via Bid Express for the performance of said Contract, and said bids have been reviewed and analyzed by the Commission's Chief Engineer, whose report concerning such analysis is before the Commission; and

WHEREAS, the Chief Engineer reports that the lowest responsive and responsible bid for the performance of Contract No. 43-15-05 was submitted by **BECDIR Construction Company**, of **Berlin Center, Ohio**, in the amount of \$2,394,498.29, which bid he recommends be accepted by the Commission; and

WHEREAS, the Commission has also been advised by the Director of Contracts Administration that bids for Contract No. 43-15-05 were solicited on the basis of the same terms and conditions and the same specifications, that the bid of BECDIR Construction Company for Contract No. 43-15-05 conforms to the requirements of Ohio Revised Code Sections 5537.07, 9.312 and 153.54, and that a performance bond with good and sufficient surety has been submitted by BECDIR Construction Company; and

WHEREAS, the Commission's Executive Director has reviewed the reports of the Chief Engineer and the Director of Contracts Administration and, predicated upon such analysis, has made his recommendation to the Commission to award Contract No. 43-15-05 to the lowest responsive and responsible bidder, BECDIR Construction Company; and

WHEREAS, the Commission has duly considered such recommendations.

NOW, THEREFORE, BE IT

RESOLVED that the bid of **BECDIR Construction Company**, of **Berlin Center**, **Ohio**, in the amount of \$2,394,498.29 for the performance of Contract No. 43-15-05 is, and is by the Commission, determined to be the lowest responsive and responsible bid received for the performance of said Contract, and is accepted, and that the Chairperson and Executive Director, or either of them, hereby is authorized to: 1) execute a Contract with said successful bidder in the form heretofore prescribed by the Commission pursuant to the aforesaid bid, 2) direct the return to the non-winning bidder of its bid security, when appropriate, and 3) take any and all action necessary or proper to carry out the terms of said bid and of said Contract; and

FURTHER RESOLVED that the Commission hereby authorizes the Executive Director and the Chief Engineer to assign to Contract No. 43-15-05, **Northwest Consultants, Inc.**, of **Toledo, Ohio**, for the purpose of performing construction administration and inspection services in accordance with the Agreement specific to the Project as previously authorized under Resolution No. 38-2014, and to assign **TTL Associates, Inc.**, of **Toledo, Ohio**, for the purpose of performing materials testing and inspection services, with such assignment in accordance with the 2015-2016 Miscellaneous Engineering Services Agreement between the Commission and said engineering firm; and

FURTHER RESOLVED that Contract No. 43-15-05 is designated a System Project under the Commission's 2013 Master Trust Agreement.
