



QUESTIONS AND ANSWERS THROUGH 12:00 P.M., SEPTEMBER 14, 2011:

Q#1 On page 4 in A. Terms of Contract it states that the term of this contract shall be twelve (12) months. On page 6b in the Bid Schedule under article it states "Removal, Transportation, Disposal and Testing of Slag Leachate Wastewater (24 Month Service). I am confused Is this a 12 month or 24 month contract? Did I misinterpret something?

A#1 The Contract is for twenty-four (24) months.

Page 4 – ADDITIONAL TERMS: In Section A, the term of the Contract is corrected to reflect the term indicated on the Bid Form of twenty-four (24) months.
