



Q#1 Please advise if a walk thru of the site will be scheduled for TRM-9F (Indian Head/Tiffin River).

A#1 As the Indian Meadow and Tiffin River Service Plazas are presently under construction, a walk-through will not be possible prior to the opening date for the RFP. A comparable set of Service Plazas that may be visited is the Blue Heron and Wyandot Service Plazas located at Milepost 76.9 in Sandusky County. 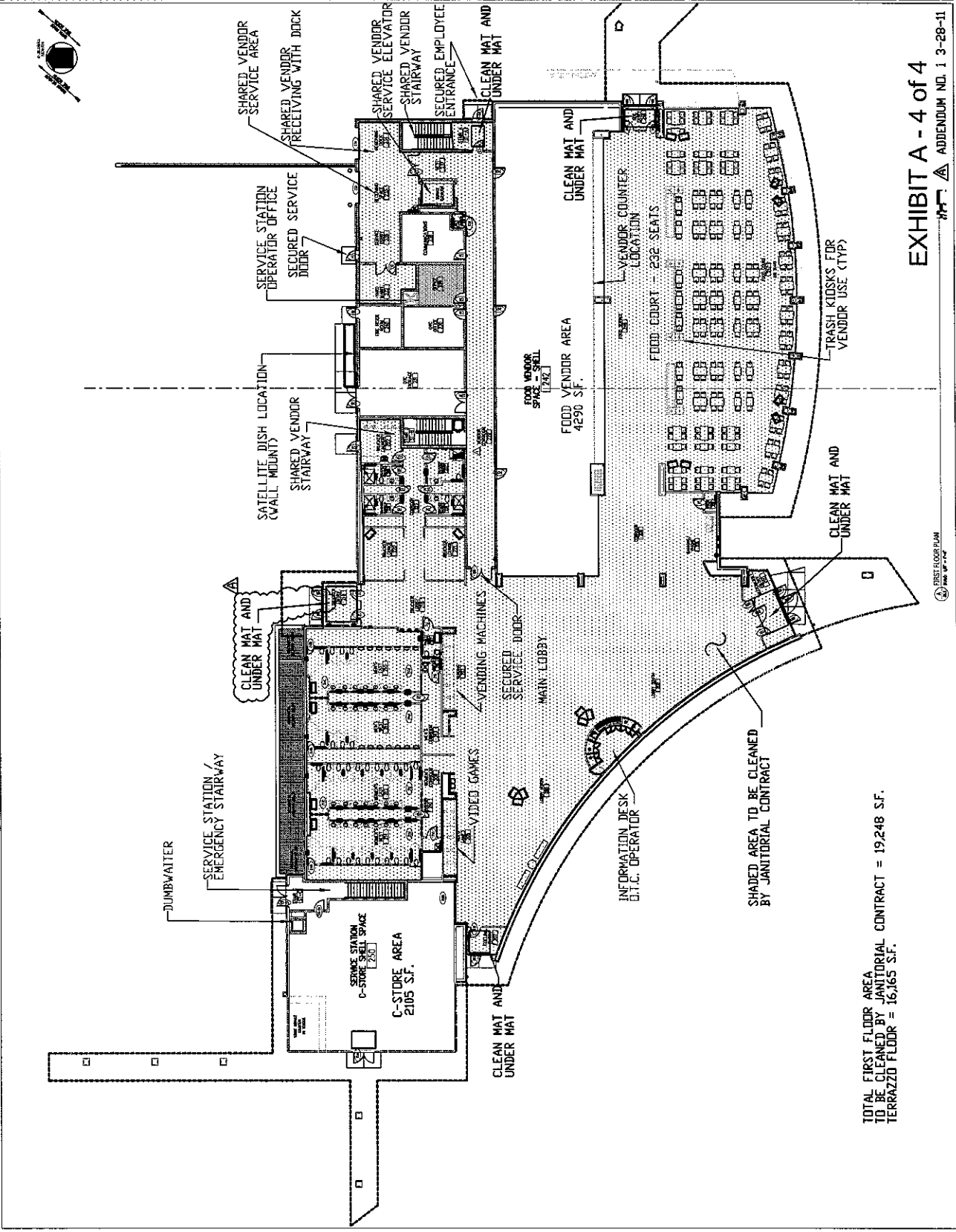
