Cover and Page 1a: NOTICE TO BIDDERS – Change E.S.T. to E.D.T.

Page 7c: SPECIFICATIONS – At the bottom of page 7c, insert the following: **“Orders: The Commission will order each different type of paper in full pallet quantities.”**

Q #1. Can you please tell me how many cases you order at one time?

A #1. *Full pallets are ordered.*

Q #2. What kind of delivery facilities do you have? Do you need inside or can you unload the paper without driver assistance?

A #2. *ALL deliveries are required via a lift gate truck because the Commission does not have a loading dock at the Berea Administration facility. Paper deliveries shall be unloaded by the driver and wheeled inside the delivery door.*

Q #3. Can you tell me how many locations you have the paper delivered to?

A #3. *As stated on page 8a under the “Delivery” Section, delivery shall be completed by and at the expense of the Contractor to the Commission’s principal office, located at 682 Prospect Street, Berea, Ohio.*

Q #4. Page 6 b, for the 11 x 17 paper substance 24, does this mean 24lb. paper is required for 11 x 17 sheet?

A #4. Yes.
