

**MW Class II Incident Responder**  
**Elmore & Castalia Maintenance Sections – Zone 3/4**  
**OHIO TURNPIKE & INFRASTRUCTURE COMMISSION**

The Ohio Turnpike & Infrastructure Commission is seeking an experienced **MW Class II “B” Incident Responder** to work in our Maintenance Department – Elmore & Castalia Maintenance Sections (Zone 3/4). Qualified applicants must reside within approximately a twenty-five (25) mile radius of one of the included zone maintenance installations assigned to by date of hire. Must possess a valid Class “A” Commercial Driver’s License (CDL) with a tanker endorsement. Paramedic or emergency first aid/medical training preferred.

Must be skilled in the operation of Incident Response vehicles and equipment; ability to identify, assess, relay information, and begin general clean-up and coordination of unusual or threatening conditions and traffic hazards; ability to protect emergency personnel, OTC maintenance personnel, and the Ohio Turnpike customers from traffic hazards, including the setup and operation of traffic control devices and vehicle-mounted arrow panels and portable changeable message boards; provide emergency first aid at accidents; provide minor road service assistance to motorist. Ability to work alone on most tasks, possess the physical ability to use rescue equipment and have effective communication skills. Knowledge of cleaning practices and procedures; highway/building maintenance practices and procedures; safety practices and procedures\*. Skilled in the operation and use of a variety of construction tools and equipment including loader, dozer, hand and garden tools, saws, mowers, jackhammers, trucks, asphalt paver, cleaning tools and equipment, traffic control, communications, rescue and safety equipment\*, etc. Possess the ability to perform the duties that are necessary for snow and ice control operations. Ability to construct projects with building materials (e.g. wood, concrete, asphalt, steel, etc.); traffic control\*, communications\*, safety equipment\*. Ability to stand, walk, or bend continuously; lift and carry 40 pounds frequently and 80 pounds occasionally.

Patrol the Ohio Turnpike to identify, plan, and coordinate the safe removal of traffic hazards, including the response to emergencies, accident scenes, disabled vehicles, roadway debris, surface spills and other incidents; provide traffic control, debris and obstacle cleanup, erect safety devices; operate fire suppression devices and equipment; assist ill or injured employees; communicate information to/from supervision and the Ohio Turnpike radio room through radio and telephone. Perform check-ups of various facilities located along the Ohio Turnpike. Provide adequately detailed log of all activities and communications. Clean, repair and maintain the Ohio Turnpike buildings, facilities, vehicles and equipment; service vehicles and equipment, including lubrication, oil change and filters, fluids. May be required to perform duties in the operation of vehicles and equipment; repair and maintenance duties including concrete and asphalt pavements, drainage, mowing, guardrail and fences, bridges, snow and ice removal, equipment preparation, service plaza pavement, access roads, toll plaza ramps and lanes; paint buildings, facilities and equipment; janitor duties; clean right of way and toll plaza lanes and building; erect traffic control and serve as a flagman; performs any other duties as may be assigned by the Division Superintendent or Section Foremen.

**SALARY**

Starting salary is \$19.50 hourly plus excellent benefits to start.

**WORK LOCATIONS & HOURS OF WORK**

Ohio Turnpike & Infrastructure Commission, Elmore Maintenance Building, Elmore, Ohio – Ottawa County Milepost 79.7 or Castalia Maintenance Building, Castalia, Ohio – Erie County Milepost 106.7. Employees do not pay tolls to and from their assigned work installations.

The “B” Incident Responder works the following schedule:

12:00 a.m. – 8:00 a.m. (winter) and 11:00 p.m. – 7:00 a.m. (summer) Thursday and Friday

8:00 a.m. – 4:00 p.m. (winter) and 7:00 a.m. – 3:00 p.m. (summer) Saturday

4:00 p.m. – 12:00 a.m. (winter) and 3:00 p.m. – 11:00 p.m. (summer) Sunday and Monday

The observed holiday schedule will be modified with these positions. Considerable overtime may be required.
