The Ohio Turnpike & Infrastructure Commission is seeking an experienced MW Class II Backup Building Checkman to work in our Maintenance Department – Castalia Maintenance Building. Qualified applicants must possess two (2) years' experience or training in commercial building/facilities repair and maintenance. A Class "A" OEPA Wastewater certification is required. Required to reside within approximately a twenty (20) mile radius of the maintenance building by date of hire. Valid Class "A" Commercial Driver's License (CDL) with tanker endorsement is also required.

Must have knowledge of highway/building maintenance practices and procedures; safety practices and procedures\*. Skilled in the operation and use of a variety of construction tools and equipment including loader, dozer, hand and garden tools, saws, mowers, jackhammers, trucks, asphalt paver, etc. Possess the ability to perform the duties that are necessary for snow and ice control operations. Ability to construct projects with building materials (e.g. wood, concrete, asphalt, steel, etc.); traffic control\*, communications\*, safety equipment\*.

Knowledge of practices associated with the maintenance and repair of building systems and equipment; diagnostic test equipment; associated safety practices; agency policies and procedures<sup>\*</sup>. Skill in operating hand and power tools related to repair and maintenance of building and equipment. Ability to understand electrical and mechanical systems, read and understand plans and specifications; work alone on most tasks; stand, walk or bend continuously; lift and carry 40 pounds frequently and 80 pounds occasionally; use mechanical equipment; radio and telephone communications<sup>\*</sup>; use limbs/fingers easily to perform manual tasks. Assigned to an approximate 30-mile section of roadway with the ability to drive throughout the distance of the Ohio Turnpike.

Assigned daily duties in the operation of vehicles and equipment; performs labor in connection with the repair and maintenance of turnpike facilities including concrete and asphalt roadway, drainage, mowing, guardrail and fences, roadway and bridges, snow and ice removal, equipment preparation, service plaza pavement, access roads, toll plaza ramps and lanes; paint buildings, facilities and equipment; janitor duties; clean right of way and toll plaza lanes and building; pavement removal and replacement; respond to emergencies, accident scenes, disabled vehicles, surface spills and other incidents; erect traffic control and serve as a flagman; communicate information to/from supervision and the radio room through radio; performs any other duties as may be assigned by the Division Superintendent or Section Foreman.

Performs the duties of the Building Checkman in the absence of the division position in the respective section; Performs operational checks, minor service and adjustment for building and physical plant equipment at service plazas, toll plazas and maintenance buildings, etc., which include heating, ventilation and air conditioning equipment, boilers, pumps, mechanical and electrical control type systems, doors, lights, fixtures, backflow prevention, generators, fire suppression systems, etc. Provides daily check and operation of water and wastewater systems; perform necessary cleaning, testing and reporting. Performs necessary checks on: potable water treatment facilities for iron removal, filtration, chlorination, etc.; wastewater treatment plant and lift/pump station flow, etc., the operation of the respective Kunkle, wastewater treatment plant and public water system is a requirement during the

absence of the respective Division Building Checkman; the operation of the respective Erie Islands and Castalia wastewater treatment plants and the Erie Islands laboratory is a requirement during the absence of the respective Division Building Checkman, and performs any other duties necessary and incidental as may be assigned by the Division Trades Supervisor.
