OHIO TURNPIKE AND INFRASTRUCTURE COMMISSION

Resolution Authorizing a Modification to the Agreement with AutoBase, Inc. for Incident Response Services Resulting in an Aggregate Not-to-Exceed Amount of \$9,900,000.00

WHEREAS, pursuant to <u>Resolution No. 67-2020</u>, adopted October 19, 2020, the Ohio Turnpike and Infrastructure Commission ("Commission") approved a contract with AutoBase, Inc. ("the Contractor") in the amount of \$1,900,000.00 for safety patrol and incident response services on the Ohio Turnpike for an initial 3-year term (the "Agreement"); and

WHEREAS, pursuant to <u>Resolution No. 50-2021</u>, adopted August 16, 2021, the Commission increased the original contract amount due to additional work shifts required as a result of the transfer of Commission-employed Incident Responder positions to a Roadway Worker position under the Collective Bargaining Agreement (CBA) for the Full-Time Maintenance Workers which resulted in a not-to-exceed contract amount of \$3,600,000.00 for the initial 3-year term; and

WHEREAS, pursuant to <u>Resolution No. 70-2023</u>, adopted August 21, 2023, the Commission exercised the first option to extend the Agreement with the Contractor for a 3-year term in the not-to-exceed amount of \$4,000,000.00, resulting in an aggregate not-to-exceed contract amount of \$7,600,000.00, with an expiration date of October 31, 2026; and

WHEREAS, the Maintenance Engineer has proposed increasing both the number of zones and shifts for the Contractor to compensate for the removal of Work Zone person requirements from several Ohio Turnpike construction projects, to provide better coverage and reduce response times, while maintaining valued services within construction zones, and the increase in coverage will require an additional amount of \$2,300,000.00 over the remainder of the current three-year term, resulting in a revised aggregate not-to-exceed amount of \$9,900,000.00; and

WHEREAS, the Maintenance Engineer recommends that the Commission approve the modification of the Agreement in the amount of \$2,300,000.00 over the remainder of the current 3-year term, resulting in an aggregate not-to-exceed amount of \$9,900,000.00; and

WHEREAS, the Executive Director and Chief Engineer/Deputy Executive Director reviewed the recommendation submitted by the Maintenance Engineer and concur with the recommendation to approve the modification of the Agreement as described above; and

WHEREAS, Commission approval is necessary because the contract modification exceeds the greater of \$150,000.00 or 10% of the original contract amount; and

WHEREAS, the Commission has duly considered such recommendations.

NOW, THEREFORE, BE IT

RESOLVED, by the Ohio Turnpike and Infrastructure Commission that the modification to the Agreement as set forth in the recitals above, in the amount of \$2,300,000.00 over the remainder of the current 3-year term, is approved, and the Executive Director is authorized to modify the agreement with AutoBase, Inc. subject to the terms and conditions of the existing agreement, resulting in the total aggregate not-to-exceed contract amount of \$9,900,000.00.
