## OHIO TURNPIKE AND INFRASTRUCTURE COMMISSION

Resolution Authorizing the Purchase of Eight (8) Trailer Mounted Attenuators from Lightle Enterprises of Ohio, LLC in the Total Amount of \$191,600.00 Under the Ohio

Department of Transportation Cooperative Purchasing Program

WHEREAS, pursuant to <u>Resolution 83-2023</u>, adopted September 18, 2023, the Ohio Turnpike and Infrastructure Commission ("Commission") is authorized to participate in contracts awarded by the Ohio Department of Transportation ("ODOT") under its Cooperative Purchasing Program for the purchase of machinery, materials, supplies, or other articles in accordance with Section 5513.01(B) of the Ohio Revised Code; and

WHEREAS, the Maintenance Engineer and Fleet and Equipment Manager have determined that the purchase of additional Trailer Mounted Attenuators is necessary to increase worker safety; and

WHEREAS, the Maintenance Engineer and Fleet and Equipment Manager recommend that the best equipment available to perform its operations is eight (8) Gregory Highway TTMA-200 Trailer Mounted Attenuator Systems; and

WHEREAS, eight (8) Gregory Highway TTMA-200 Trailer Mounted Attenuator Systems are available for acquisition through the Ohio Department of Transportation ("ODOT") Cooperative Purchasing Program, under ODOT Contract No. 060-26, from Lightle Enterprises of Ohio, LLC in the total amount of \$191,600.00; and

WHEREAS, the Executive Director and the Chief Engineer/Deputy Executive Director reviewed the recommendation of the Maintenance Engineer and Fleet and Equipment Manager and concur with the recommendation that the Commission approve the purchase of eight (8) Gregory Highway TTMA-200 Trailer Mounted Attenuator Systems from Lightle Enterprises of Ohio, LLC under the ODOT Cooperative Purchasing Program, and

WHEREAS, Commission action is necessary under Article V, Section 1.00 of the Commission's Code of Bylaws because the expenditure required to purchase eight (8) Gregory Highway TTMA-200 Trailer Mounted Attenuator Systems exceeds \$150,000.00; and

WHEREAS, the Commission has duly considered such recommendations.
