Sealed Bids will be received by the Ohio Turnpike and Infrastructure Commission (“Commission”) from Bidders subscribing to Bid Express (<https://www.bidexpress.com>) and selecting the following Project for Bidding:

#### **PROJECT NO. 39-17-01**

#### **MAINLINE PAVEMENT RECONSTRUCTION MILEPOST 90.00 TO MILEPOST 95.90, EASTBOUND SANDUSKY COUNTY, OHIO**

Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

**Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.**

**The Small Business Enterprise Goal (SBE/DBE/EDGE) applicable to this Project is 10%.**

**Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’ Risk Insurance is not required under GC Art. 12.2 for this Project.**

Bids will be received for Project No. 39-17-01, which includes the following:

The Work to be performed under the Contract, if any is awarded on the basis of the Bids, consists of removing and reconstructing 5.90 miles of pavement in the right two (2) eastbound lanes and shoulder along the Ohio Turnpike. The Work includes excavating the existing pavement and replacing it with a new pavement section, chemically stabilizing the subgrade, making slope repairs, performing drainage repairs and replacements, installing asphalt curbs, guardrail, pavement markings and other traffic control devices, performing temporary traffic control and performing bridge maintenance on six (6) structures. The bridge maintenance Work includes, but is not limited to, repairing the deteriorated surfaces of the bridge decks and abutment slabs, replacing approach slabs, patching concrete, resetting, repairing and replacing bearings, trimming beam ends, removing and replacing expansion joint armor and associated concrete repairs, removing and replacing expansion joint seals, repairing painting of structural steel and concrete weatherproofing. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 39-17-01.

Bids will be accepted until **October 28, 2016, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. To avoid a potential extension of the Bid Opening date and/or a potential rejection of all Bids, it is imperative that Bidders submit all questions in a timely manner and no later than seven (7) days prior to Bid Opening.
