Sealed Bids will be received by the Ohio Turnpike and Infrastructure Commission (“Commission”) from Bidders subscribing to Bid Express (<https://www.bidexpress.com>) and selecting the following Project for Bidding:

Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

**Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.**

**The Small Business Enterprise Goal (SBE/DBE/EDGE) applicable to this Project is 10%.**

**Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’ Risk Insurance is not required under GC Art. 12.2 for this Project.**

Bids will be received for Project No. 39-18-02, which includes the following:

The Work to be performed under the Contract for Project No. 39-18-02 PART A, if any is awarded on the basis of the Bids, consists of removing and reconstructing 6.6 miles of pavement in the right two (2) lanes and shoulder in both directions of the Ohio Turnpike along with the removing and reconstructing 3.04 miles of the westbound third lane. The Work includes, but is not limited to, excavating existing pavement, removing and disposing of existing slag base and bridge fill, chemically stabilizing the subgrade, constructing full depth asphalt pavement, making minor slope repairs, performing drainage repairs and replacements, performing culvert rehabilitation, removing trees, replacing right of way fence, installing concrete barrier wall, asphalt curbs, guardrail, pavement markings and other traffic control devices, performing temporary traffic control, installing new ramp light foundations, light poles and pull boxes, repairing MSE

wall, milling and paving two (2) inches of asphalt pavement in the third lane and left shoulder and performing bridge maintenance on four (4) mainline structures. The bridge maintenance Work includes, but is not limited to, performing approach slab replacements, parapet replacements, patching concrete, removing and replacing expansion joint armor and associated concrete repairs, removing and replacing the expansion joint seals, concrete weatherproofing and patching and sealing of one (1) overhead structure.

The Work to be performed under the Contract for Project No. 39-18-02 PART B, if any is awarded on the basis of the Bids, consists of removing and reconstructing a portion of Interchange 173 Ramps and resurfacing the balance of the interchange ramps. The Work includes, but is not limited to, excavating the existing ramp pavement, chemically stabilizing the subgrade, constructing full depth asphalt pavement on a portion of the interchange, performing drainage repairs and replacements, asphalt curbs, guardrail, pavement markings and other traffic control devices, performing temporary traffic control. Work on the balance of the interchange pavement will include milling one (1) inch of existing concrete pavement, making full depth concrete repairs and then paving 3-1/4" of asphalt over milled concrete pavement.

All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 39-18-02.

Bids will be accepted until **February 1, 2018, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. To avoid a potential extension of the Bid Opening date and/or a potential rejection of all Bids, it is imperative that Bidders submit all questions in a timely manner and no later than seven (7) days prior to Bid Opening.

Contract Documents are available by registering for a free vendor account and logging into Bid Express® (<https://www.bidexpress.com>). However, Bidders must obtain a paid subscription to Bid Express and select the Project for Bidding to submit a Bid.
