Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.

All Bidders entering into a Contract on a Commission-administered Project and their Subcontractors will be required to be enrolled, and in good standing in a “Drug-Free Safety Program” approved by the Ohio Bureau of Workers’ Compensation.

Pollution Liability Insurance is not required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.3.1 for this Project.

Bids will be received for Project No. 43-16-06, which includes the following:

Replacement of bridge deck, bearing devices and expansion joints; miscellaneous patching of substructure; sealing of construction joints; performing concrete weatherproofing; maintenance of traffic; installing fencing; and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 43-16-06.

Bids will be accepted until **November 4, 2015, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. To avoid a potential extension of the Bid

Opening date and/or a potential rejection of all Bids, it is imperative that Bidders submit all questions in a timely manner and no later than seven (7) days prior to Bid Opening.
