Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Bids will be received for Project No. 43-17-04 (RE-BID), which includes the following:

Overlay of the bridge deck, rehabilitation of the expansion joints; miscellaneous patching of substructure; sealing of construction joints; hydrodemolition and application of an overlay; performing concrete weatherproofing at the bridge at Milepost 138.0; removal of the bridge at Milepost 138.2 and replacing it with fill and pavement on grade; maintenance of traffic; and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 43-17-04 (RE-BID).

Bids will be accepted until **January 31, 2018, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
