Replacement of the bridge at M.P. 59.0 including, bridge deck, expansion joints, fencing, bearings, and substructure; and replacement of the bridge deck at M.P. 84.4 including the bridge deck, expansion joints; miscellaneous patching of substructure; sealing of construction joints; performing concrete weatherproofing; maintenance of traffic; installing fencing; and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 43-18-02.
