Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2.1 for this Project.

Bids will be received for Project No. 43-19-02, which includes the following:

Removal of the bridge at Milepost 34.2 and replacing it with fill and pavement on grade; Replace the existing deck and widen the decks on the twin mainline bridges at M.P. 34.5; Replace the existing deck on the bridge at MP 35.2. Additional rehabilitation work at the two bridges to remain include replacement of the expansion joints and bearings; miscellaneous patching of the substructure, sealing of all construction joints; performing concrete weatherproofing; maintenance of traffic; and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 43-19-02.

Bids will be accepted until **February 13, 2019, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
