The Work consists of adding 2.9 miles of new third lane and median shoulder in both directions of the Ohio Turnpike including grading, drainage, asphalt pavement, chemically stabilizing the subgrade and permanent concrete barrier. Also, removing and reconstructing 1900 feet of pavement in the right two (2) lanes and shoulder in both directions of the Ohio Turnpike. The Work includes, but is not limited to, excavating existing pavement, chemically stabilizing the subgrade, construct full depth pavement, performing drainage repairs and replacements, asphalt curbs, guardrail, pavement markings and other traffic control devices and performing temporary traffic control. Replace the existing deck and widen the decks on the twin mainline bridges at M.P. 47.4 and M.P. 47.5. Additional rehabilitation work at the bridges include replacement of the expansion joints and bearings; miscellaneous patching of the substructure, sealing of all construction joints; performing concrete weatherproofing; maintenance of traffic; and all other items incidental to the completion of the Work.
