All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No.’s 53-18-04 and 53-18-05. The Work includes, but is not limited to, the following:

- Demolition of TPO membrane, base and penetration membrane flashings, metal penetration flashings, metal perimeter flashings, insulation, etc. as identified in the Plans, Special Provisions and Technical Specifications.
- Installation of new PVC membrane, insulation, vapor barrier, wood nailers, walk pads, PVC base and penetration flashings, metal penetration, counter and perimeter flashings, etc. as identified in the Plans, Special Provisions and Technical Specifications.

- Repair/replace steel deck, deteriorated wood, damaged insulation, roof drain components and provide additional walk pads as needed.
- Obtain inspections, perform all incidental work required to complete the work as shown in the Plans, provide fuel canopy traffic control and foot traffic control as needed, adhere to work restrictions as noted in the Plans.
