Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.

All Bidders entering into a Contract on a Commission-administered Project and their Subcontractors will be required to be enrolled, and in good standing in a “Drug-Free Safety Program” approved by the Ohio Bureau of Workers’ Compensation.

Pollution Liability Insurance is not required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is required under GC Art. 12.2 for this Project.

Bids will be received for Project No. 56-15-08, which includes the following:

Furnish and construct a custom pre-engineered steel building at the Hiram Maintenance Building location. The Contractor shall: provide a building that meets the Specifications, the building system manufacturer’s recommended requirements and the State of Ohio Requirements; provide building plans and requested submittals for approval by the Commission; submit plans approved by the Commission to the State of Ohio for Plan Review; perform final grading for the new building floor and foundation; construct the building (including final finish grading, raised foundation, floor, structural steel, walls, roof, doors, lighting, ventilation system, etc.; maintain a clean and safe work site; provide to the Commission signed permits, as-built drawings, building and mechanical equipment manuals and warranties, etc. All Work is to be performed as per the

Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 56-15-08.

Bids will be accepted until **September 15, 2015, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. To avoid a potential extension of the Bid Opening date and/or a potential rejection of all Bids, it is imperative that Bidders submit all questions in a timely manner and no later than seven (7) days prior to Bid Opening.
