Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

**Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.**

**All Bidders entering into a Contract on a Commission-administered Project and their Subcontractors will be required to be enrolled, and in good standing in a “Drug-Free Safety Program” approved by the Ohio Bureau of Workers’ Compensation.**

**Pollution Liability Insurance is not required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is required under GC Art. 12.3.1 for this Project.**

Bids will be received for Project No. 56-15-09, which includes the following:

Disconnect existing rooftop unit, remove from roof, provide and install new rooftop unit, new curb, new duct (as indicated), new VAV boxes with electric reheat, new supply and return air diffusers, new variable speed exhaust unit and new volume dampers, provide and install new ceiling grid and tile, perform air balance, provide roof repairs, perform all gas and electric connections, properly seal/repair all wall, ceiling and roof penetrations. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 56-15-09.

Bids will be accepted until **April 7, 2016, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud.
