Bids will be received for Project No. 56-16-03, which includes the following:

Installation of new catch basins and connected piping, installation of underdrains, installation of new full depth pavement by excavating the existing aggregate, pavement, and chip and seal material and installing asphalt concrete base, intermediate and surface courses. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 56-16-03.
