Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

The Small Business Enterprise (DBE/EDGE/SBE) Goal applicable to this Project is 10%.

Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2.1 for this Project.

Bids will be received for Project No. 59-18-04 (Re-Bid), which includes the following:

Removal by milling of two (2) inches of existing asphalt pavement at locations specified in the Plans, resurfacing of the pavement with two (2) inches of plan material at the locations specified in the Plans, removal and installation of raised pavement markers and permanent pavement striping and/or other pavement markings, and temporary traffic control, in both Eastbound and Westbound roadways. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 59-18-04 (Re-Bid).

Bids will be accepted until **July 3, 2018, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
