Bids will be received for Project No. 59-19-01, which includes the following:

Removal by milling of three (3) inches of existing asphalt pavement in the left and right lane of the mainline, removal by milling of two (2) inches of existing asphalt in the left and right shoulders, mill and fill of the Sonic Nap Alert Pattern (“SNAPs”) in the left and right shoulders, resurfacing of the pavement and shoulders to the thickness specified in the Drawings, partial eastbound shoulder reconstruction, concrete approach slab removal and replacement, concrete weatherproofing of bridges, full depth pavement repairs, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, upgrading of guardrail, installation of SNAPs, and temporary traffic control, in both Eastbound and Westbound lanes. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 59-19-01.

Bids will be accepted until **February 5, 2019, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
