Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements apply to this Project.

The Small Business Enterprise (DBE/EDGE/SBE) Goal applicable to this Project is 10%.

Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2.1 for this Project.

Bids will be received for Project No. 59-19-02, which includes the following:

Removal by pavement planing of three and one-half (3 1/2) inches of existing asphalt pavement in the left lane and two (2) inches of existing asphalt pavement in the left shoulder of the mainline, resurfacing of the pavement and shoulders to the thickness specified in the Drawings, repair of median inlets/catch basins, concrete weatherproofing of bridges, permanent pavement striping and/or other pavement markings, and temporary traffic control, in both Eastbound and Westbound lanes. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 59-19-02.

Bids will be accepted until **May 3, 2019, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
