Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

**Prevailing Wage Rates and Equal Employment Opportunity requirements apply to this Project.**

**The Small Business Enterprise (DBE/EDGE/SBE) Goal applicable to this Project is 5%.**

**Pollution Liability Insurance is not required under GC Art. 12.1.4 for this Project.  
Builder’s Risk Insurance is required under GC Art. 12.3.1 for this Project.**

Bids will be received for Project No. 64-17-01, which includes the following:

The Work to be performed under the single General Contract that will be awarded consists primarily of structural and electrical Work required to retrofit fourteen (14) existing toll booths along the Ohio Turnpike to allow the installation of new Automated Toll Payment Machines (“ATPM”). There is one (1) booth to be modified at Ohio Turnpike Toll Plaza TP-180. There are two (2) booths to be modified at each of the following Ohio Turnpike Toll Plazas: TP-59, TP-110, TP-118, TP-142, and TP-209. There are three (3) booths to be modified at Ohio Turnpike Toll Plaza TP-64. There is also Work at all the toll plaza buildings associated with each toll booth. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 64-17-01. The Work includes, but is not limited to, the following:

- Provide and install new conduit, junction boxes, wire, load centers, breakers, etc. as shown in the Plans.

- Provide and install new bollards, structural framing, concrete pad, building trim, temporary wood frame and plywood enclosure, etc. as shown in the Plans.
- Perform exterior and interior wall penetrations, install ATPM camera junction boxes and cables in flexible conduit, pull power and data cable, remove and/or relocate thermostats, switches, conduit, junction boxes, load centers, phone jacks, radio-telephone panels, wall heaters, fare displays, etc. as shown in the Plans.
- Demolition sections of toll booth walls (structural, interior and exterior finishes) and concrete flooring as needed to complete the electrical work and as shown in the Plans.
- Obtain inspections, perform all incidental work required to complete the work as shown in the Plans, provide traffic control as needed, adhere to toll booth availability and restricted hours requirements as noted in the Plans.

Bids will be accepted until **March 29, 2018, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
