Bids will be received for Project No. 70-19-01, which includes the following:

Rehabilitation of specified roadway embankments; full depth removal and replacement of shoulder pavement, repair of mainline catch basins and associated conduits; removal, replacement and/or upgrade of existing guardrail; permanent pavement striping and/or other pavement markings, installation of SNAP’s; temporary traffic control and all other items incidental to the completion of the Work.
