PROJECT 75-18-01A (RE-BID)

Reconstruction of a soil remediation Bio-Pile utilizing remaining contaminated soil organized by square/rectangular quadrants. The reconstruction of a six (6) foot tall stockpile of contaminated soil with a system of perforated piping, regularly spaced vertical vents, surrounded by soil berms, and is entirely covered by an impervious liner exposed to northern Ohio environmental conditions. The existing/proposed system of perforated piping will be connected via non-perforated piping to salvaged enclosures that contain vacuum pump units

(pump units installed by others) that are intended to create an air exchange within the Bio-Piles.

or;

PROJECT 75-18-01B (RE-BID)

The total removal of the petroleum contaminated soil (PCS) and all associated piping valves, PVC linings and covers, metal cabinet enclosures, and any other items pertaining to the Bio-Piles. All electrical service wires will be removed from the electrical conduit and conduit left in place.

All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 75-18-01A (RE-BID) or 75-18-01B (RE-BID).

Bids will be accepted until **July 26, 2018, at 2:00 P.M. (Eastern Time),** when all Bids will be accessed, opened and read aloud. <u>Bidders should submit all questions no later than</u> seven (7) days prior to Bid Opening.
