Remove two (2) inches of existing asphalt pavement, apply tack coat, replace asphalt pavement and compact material with asphalt pavement rollers, existing lines and grades shall be followed to ensure adequate drainage, clean the area of any excess materials, all Work shall be performed during daytime hours. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 99-17-03.
